

## MANAGEMENT PROTOCOL FOR CONTRAST COVID-19 BEHAVIORAL MEASURES

The ongoing health emergency related to the spread of the SARS n-cov-2 virus and the disease identified as Covid-19 requires everyone to adopt simple but effective prevention and protection measures.

These measures must be applied in everyday life but in particular in the workplace also with regard to the current legislation on Health Safety in the Workplaces Legislative Decree 81.08 and subsequent amendments.

Specifically, for the matches of the competition called " \_\_\_\_\_ ", a Regulatory Protocol was established to combat the virus, which was drawn up on the basis of current regulations and guidelines issued by the Italian Rugby Federation and / or other Organizational Bodies.

The Protocol established provides for specific procedures for access and circulation within the stadium and for the management of the tasks required for each authorized activity, which all accredited persons must strictly comply with.

In particular:

- Access will be allowed only to persons accredited by F.I.R. and equipped with an identification pass and nominative access ticket that will be worn in a visible manner for the entire duration of the stay inside the stadium; the pass and the admission ticket are nominative and cannot be transferred.
- Access will be allowed only to people who present the self-certification established by F.I.R. (Annex 1) and who will demonstrate or declare compliance with the provisions contained therein.
- Under no circumstances will entry be granted to people with obvious symptoms related to Covid.
- All participants are therefore required to take maximum responsibility in this regard and not to show up if they have symptoms referable to Covid or have the certainty or suspicion that they have come into contact in the previous 14 days with symptomatic people or for whom the virus positivity or Covid-19 positivity is being ascertained.
- All participants must be aware that for entry to restricted areas (red zone) they may be required to undergo molecular testing (PCR) for the SARS N-Cov-2 virus.
- The specific health authority, in particular conditions, could subject the participant to tests for the virus, even if not accredited for the restricted access area.
- For access, the measurement of body temperature will be mandatory, which cannot be equal to or higher than 37.5 ° C. Values very close to those indicated may in any case be subject to in-depth evaluation by the medical team in support of the Organization.
- Persons recognized as "fragile" must have had the express authorization to carry out their work activities from their doctor.
- Persons for whom a temperature equal to or greater than 37.5 ° C will not be able to access the stadium and will have to return to their home by informing their general practitioner, the specific ASL or by contacting the toll-free **number of the Veneto Region 800462340** established within the Covid emergency.
- The plant / stadium will be divided into 4 distinct areas identified as follows:
  - Red zone.
  - Amber zone.
  - Green zone.
  - Park zone.
- The pass of the accredited persons will be specific for one or more of these areas and it will be strictly forbidden to enter even for very short periods in the areas for which one is not authorized, except for written and demonstrable exceptions or concessions.
- In particular, the red zone is identified as a biosecurity area with restricted access, where the maximum conditions of segregation, quotas and respect for safety distances must be guaranteed; for no reason those not authorized to enter this area will be able to access it.

- Inside the stadium, both indoors and outdoors, **the use of a surgical mask or a higher filtering level (FFP2-FFP3) is mandatory for the entire time spent** subject to specific indications on the category of the device to be used according to the task to be performed or the area in which it will be conducted.
- Respect for interpersonal safety distances of at least 1 meter, raised to 2 meters within the red zone, is mandatory for the entire time inside the stadium.
- Handshakes and hugs and any form of gathering both indoors and outdoors are prohibited.
- Compliance with the maximum crowding limits for areas and premises is mandatory. Compliance with the indicated routes is mandatory.
- It is mandatory to resort to frequent hand sanitation through the use of disinfectant products placed in the areas and premises of the stadium.
- It is mandatory to immediately report the presence of symptoms related to Covid that may arise during the stay inside the stadium.
- In these cases, the person who present symptoms could be taken to special isolation rooms, where they will have to wait for the intervention of the health personnel in charge.
- **It is forbidden to smoke outside the areas indicated and in any case in all those where there is a "no smoking" sign.**
- It is forbidden to eat meals outside of the procedures provided by the organizer who will have specific procedures for the supply and consumption of food and drinks.
- It is forbidden to share food and drinks with others present. Where permitted by the organizer, these must be consumed in compliance with the indicated hygiene measures and social distancing.
- Where present and authorized, the drinks must be kept in the original container with closure and used so that there is no possibility that they will be shared or mistakenly exchanged among others present.
- It is forbidden to abandon, even for short periods, masks and other protective devices or medical devices. The same will be eliminated using the appropriate containers.
- It is mandatory to follow the instructions of the staff responsible for managing the health risk.
- It is mandatory to disinfect all equipment to be introduced inside the stadium.
- People who do not comply with the procedures established in favor of an appropriate fight against the virus, will be immediately removed from the stadium and reported to the indicated authority.
- In the event of a positive response to Covid in the days following the event, it is mandatory to report the event to the Organizer through your contact person.
- All accredited persons present at the event must make themselves available for any contact tracing activities that may become necessary in the days following the event.
- Depending on what is reported in the previous point, it is necessary, to access the stadium, to provide your personal details, your contact details (tel- address and email).

Movements within the stadium must be limited to the bare minimum and in compliance with the Organizer's instructions. During the hours of activity, you can move around the venue of the event according to your function, your pass, your tasks / instructions and the coordination in this regard with the DGE (Delegate for the Management of the Event) and / o of the GOS (Safety Operating Group), respecting the merit requirements regarding the use of PPE, segregation of the areas and the maximum crowding indexes reported in the areas and premises where it will have to transit or access. It is also mandatory to comply with the Stadium Regulations, all safety indications, and relating to tampering with systems and equipment, the provisions on fire prevention, the emergency procedures reported, the ban on smoking.
